I hereby voluntarily waive any and all claims resulting from ordinary negligence, both present and future, that may be made by me, my family, estate, heirs or assigns.

Further, I am aware that baseball is a vigorous sporting activity involving bats and balls in a unique environment and as such they pose a risk of injury. I understand baseball and related activities always involve certain risks, including but not limited to death, serious neck and spinal injuries resulting in complete or partial paralysis, brain damage and serious injury to virtually all bones, joints, muscles and internal organs and other safety equipment and apparatus provided for my protection, including the active participation of a coach or teacher who will model or assist in the performance of certain skills may be inadequate to prevent serious injury.
